RELEASE OF LIABILITY

Camping or hiking are outdoor activities that can be dangerous to individuals if they are not careful. At an outdoor site, such as the property owned by Timberidge, Inc., injury to an individual, including serious injury, could result from many things such as vehicular traffic, fire, trees, rough or uneven terrain, slippery mud, sharp rocks or broken glass and other natural obstacles. No attempt has been made by Timberidge, Inc., its officers, its members or any guests to locate, remove or otherwise reduce any hazards on the Timberidge, Inc. property. EACH INDIVIDUAL WHILE ON THE TIMBERIDGE, INC., PROPERTY MUST WATCH OUT FOR THEIR OWN SAFETY AND EACH INDIVIDUAL SHALL BE RESPONSIBLE FOR THEIR OWN SAFETY AND EACH INDIVIDUAL SHALL NOT RELY ON ANY OTHER PERSON TO DO THIS FOR THEM. IF YOU ALLOW CHILDREN TO COME TO THE TIMBERIDGE, INC. PROPERTY, YOU MUST WATCH OUT FOR THESE CHILDREN'S SAFETY OR ARRANGE FOR A RESPOSIBLE ADULT TO DO SO, AND YOU OR THAT ADULT SHALL BE RESPONSIBLE FOR THE SAFETY OF THE CHILDREN YOU ALLOW TO COME TO THE TIMBERIDGE, INC. PROPERTY AND YOU SHALL NOT RELY ON ANY OTHER PERSON TO DO THIS FOR THE CHILDREN YOU ALLOW TO COME TO THE TIMBERIDGE, INC. PROPERTY.

Timberidge, Inc, an Ohio non-profit corporation, (hereinafter the Camp) its officers and Members, (Member being any properly admitted member of Timberidge, Inc.) shall not be liable for any damages arising from damage to personal property or personal injuries sustained by Member, or any Guest, defined as a non-Member, while a Member or Guest is participating in any program or activity related to or while on Camp property and each Member or Guest participating in any program or activity related to or on Camp property does so at his or her own risk.

In consideration for being able to participate in any Camp activity or program or any activity or program taking place on the Camp property, a Member or Guest assumes full responsibility for any injuries or damages which may occur to the Member or Guest in the course of such programs and activities and he or she does hereby fully and forever release and discharge the Camp, its officers and Members, from any and all claims, demands, damages, rights of action, or causes of action, present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of the Member's or Guest's participation in

programs and activities, including from or arising out of the negligence of the Camp, its officers or Members or any other persons present at said programs or activities. Each Member or Guest agrees that they (the Member or Guest) shall pay the full cost of any legal defense that the Camp, it officers or any Member incurs in defense of any claim that such Member or Guest might bring in contravention of this release without regard to the merits of such Member's or Guest's claim against Timberidge, Inc. or any other party.
